1. General description

The 74LVC04A is a hex inverter. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.








Fig. 6. The input (nA) to output (nY) propagation delays




Fig. 7. Test circuit for measuring switching times




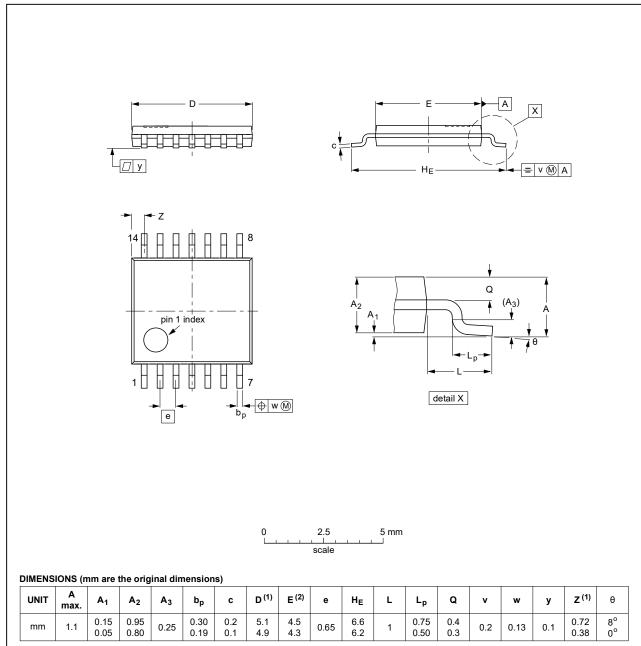


Fig. 9. Package outline SOT337-1 (SSOP14)




Fig. 11. Package outline SOT762-1 (DHVQFN14)
